NOTIFICATION

Through this publication, the Government of the Country of Curaçao announces that the retail prices for the products Mogas 95, Gasoil LSD, LPG 100 lbs and LPG 20 lbs, shall be adjusted as per 4 November 2013.

In view of the frequent fluctuations in the international oil prices, the government feels obliged to proceed to:

1. the monthly adjustment of the retail prices, and;
2. the publication of the current and new end user rates per product.

From 30 September 2013 to 3 November 2013, the price breakdown for Mogas 95, Gasoil LSD, LPG 100 lbs and LPG 20 lbs, shall be as follows:
