You must have proper measuring equipment at your disposal. At question 2.3 you will find a list of the required measuring equipment. Fill in the brand and model information for each. If certain measuring equipment is built-in in a meter cabinet, fill in the brand and model information of the meter cabinet.

- 2.4. You must employ an electrical engineer who has successfully completed an education of at least the level of Technical Secondary School – Electrical Engineering Department or an equivalent of this. The electrical engineer charged with selling equipment that is for sale must also hold certificates of successfully completed training programs of the suppliers and/or manufacturers of the sold equipment.
- 2.5. The workshop where the equipment is sold and where the measuring equipment is located must have a floor space of at least 9m². You must submit a floorplan from which it is evidenced that your workshop complies with this. BT&P must first perform a proper inspection of the workshop and the equipment contained within, before equipment can be sold, traded, exported, supplied or leased out.
