Explanation

The slight increase in the electricity tariffs is mainly the result of lower average fuel expenses for the production of electricity in combination with the expected production-mix and a higher correction factor for the month of October 2023. The decrease in the water tariffs is the result of a slight increase in the electricity expenses for the production of water in combination with a lower correction factor for the month of October 2023.
