## **Explanation**

The decrease of the electricity tariffs is the result of a decrease in the average fuel expenses for the production of electricity due to a partial switch to more economic fuel (Marine Gasoil to Marine Fuel Oil) in combination with the expected production-mix and a higher correction factor over the month February 2024. The decrease in the water tariffs is the result of a decrease in the electricity expenses for the production of water in combination with a higher correction factor over the month February 2024.
